

#### Minerals and Waste Planning

Lancashire County Council, working jointly with Blackburn with Darwen and Blackpool borough councils, is in the early stages of preparing a plan that sets out policies for mineral working and waste development in Lancashire.

The plan, known as the Minerals and Waste Development Framework (or MWDF), will be made up of a series of documents, and will focus on issues such as:


- mineral extraction;
- waste disposal and recycling;
- protecting mineral resources; and
- restoration of minerals and waste sites.

Key to developing the MWDF will be the involvement of Lancashire's residents. We will be producing a 'Statement of Community Involvement' which will set out how we propose to involve local people in the preparation of framework documents.
