Lancashire County Council Budget and Priorities

We want to ask you some questions on what you think about the county council's service priorities, and the council tax we charge. The questions first have some brief background information on the budget and on council tax.

Priorities

Background

In the current financial year April 2005 to March 2006 the county council will spend £1,464 million.

£325 million of that total spending is funded from government grants and from fees and charges that the council makes for specific services.

This leaves a net spend of £1,137 million. The table below shows how this will be spent.

Council Tax

Background

The County Council's spending is funded from three sources. Funding for 2005/06 is:

Business rates and revenue support grant are fixed sums of money from the government. The County Council sets council tax according to how much more it needs to pay for total spending.

The County Council set a spending budget of £1,137 million for 2005/06. We received £779 million from the government, leaving a balance of £358 million to be raised from council tax.

For a household in band D this meant a council tax charge of £950.29 for the year, equivalent to £18.27 a week. This was an increase of 2.5% on the previous year, which was well below the average increase of 3.8% for county councils in the UK.

In a shire county area like Lancashire the council tax bill also includes charges from the borough or district council, the police authority, the fire authority and sometimes the local parish council.

Next year

We don't yet know how much grant the council will get from the government next year. But we do know that there will be major changes to how the county council is funded. From 2006/07 schools will be separately funded by a new "dedicated schools grant". The government will hold back business rates and revenue support grant to fund this new grant for schools, which will mean that the council will receive less grant from the government for other services. This reduced level of grant together with council tax will be used to fund services other than schools.

In its spending review in 2004, the government indicated that it assumed council tax would increase by about 5% in 2006/07. However, recent information indicates that the increase in grant from the government next year may now be lower than previously thought. And this in turn means that the council tax increase would need to be even higher than the 5% assumption - possibly over 7% - to fund the level of spend planned by the government.

In addition to this pressure on funding, pressures on our spending are also higher than those allowed for in the government's plans: for example, rapidly rising energy costs, higher costs of waste recycling compared with landfill disposal, and increased costs for children's and adults' care services.

These pressures on council tax from both the funding and spending sides mean that council tax will probably need to increase by much more than current level of inflation to maintain our current level of services.
